What You and Your Service Facilitator Should be Discussing

1. New for this period:

- 1. If you are on the EDCD waiver Are you on the wait list for the ID or DD Waiver if applicable?
 - See our document Which Waiver Wait List Should I be on?
- 2. Review Mobility and Behavior/Orientation levels as noted on our reports. Are they accurately reflecting your reality?

2. At every visit:

- 1. Are you enrolled in <u>Commonwealth Coordinated Care (CCC)</u>? If so, which Managed Care Organization (MCO) are you using?
- 2. Any medical and/or functional changes.
- 3. Who are your attendants and are they getting paid?
- 4. Have there been any recent hospitalizations?
- Turning 18 We have an amazing <u>resource page</u> for young adults on our website.

Help Moms in Motion Serve You Best!

Moms in Motion is the best provider of our services in Virginia because we want you to have all of your needs met. We'll work together with you to achieve this goal. We must stick to a schedule so we can continue to serve

you.

If you are new to Moms in Motion we will typically visit you every 30 days for the first year. After this period our visit frequency may be changed to every 60 or 90 days depending on which Waiver you are enrolled in. If you are enrolled in the ID Waiver Moms in Motion preferred to continue to see you every 30 days as the administration of this waiver requires more regular contact.

Your service facilitator should be seeing you at least every 30, 60, or 90 days. If not, please alert the **Division Manager** in your area.

If you are enrolled in the EDCD Wavier and on the DD Waiver wait list, you should be visited by your Moms in Motion Service Facilitator AND your Moms in Motion Case Manager until you receive a funded DD slot. Your Case Manager will call you every month and visit you every 90 days.

Reminder: There is no wait list for EDCD Waiver.

Waiver Redesign Update

Beginning July 2016, the Commonwealth will be launching a new I/DD Waiver program for Virginians with intellectual and developmental disabilities. The program will replace the existing Intellectual Disability (ID) Waiver and Developmental Disability (DD) Waiver with three new waivers:

- Community Living (CL) Waiver
- Individual and Family Support (IFS) Waiver
- Building Independence (BI) Waiver

Individuals currently receiving ID/DD Waiver services will be offered the opportunity to choose which of these three Waivers they will receive when they transition into the new program.

Update on Department of Medical Assistance Services' (DMAS) proposed Medicaid Managed Long Term Services and Supports (MLTSS) initiatives

DMAS has revised the two-phased approach and will now transition these feefor-service (FFS) Medicaid enrollees through a single comprehensive procurement and implementation plan. DMAS will implement a single mandatory Medicaid Managed Long Term Services and Supports (MLTSS) program beginning mid-year 2017. Read more



Advocacy

US vs. Virginia Settlement Agreement

A status hearing regarding the U.S. v. Virginia Settlement Agreement has been scheduled for October 23, 2015 at 10:00am at the Federal Courthouse in Richmond. This is the first hearing regarding implementation of the U.S. v. Virginia Settlement Agreement, and it will be open to the public. Read about the development of this agreement.

How to Prevent Service Cuts and Protect Consumer- Directed Programs

The Department of Labor's (DOL) Home Care Rule will go into effect on October 13, 2015 (regarding <u>overtime and wages</u> for Personal Care Attendants) unless the Supreme Court takes action.

The disability community's input is vital in ensuring that states do not cut services, dismantle programs that allow consumers to control our services, or place caps on worker hours and earnings.

<u>The Virginia Board for People with Disabilities</u> annual consumer satisfaction <u>survey</u>.

Your time is valuable and the survey should only take about 10-15 minutes to complete. The Board greatly appreciate your input. It helps us to improve our advocacy, policy, outreach, training, and grant activities. The survey is open until October 16.

The Board encourages individuals with disabilities, their families, service providers, policymakers, advocates, and other concerned citizens to complete the following annual Consumer Satisfaction and Stakeholder Feedback Survey. Individual responses are anonymous and confidential.

Results of the survey will be used to plan and improve future Board activities. Total results must be reported to our federal funding and oversight agency, the U.S. Administration on Intellectual and Developmental Disabilities. Your feedback will play an important role in ensuring the quality and support of the Board's mission on behalf of Virginians with disabilities.

The Inclusive Home Design Act

On July 28, 2015, during the Rally at the Capitol during NCIL's 2015 Annual Conference on Independent Living, Illinois Representative Jan Schakowsky announced that she would be introducing the <u>Eleanor Smith Inclusive Home Design Act</u> that very day. The Inclusive Home Design Act is a bill that would have federally funded single-family homes incorporate <u>Visitability</u>.

Autistic Self Advocacy Network- Autistic Scholars Fellowship

The Autistic Self Advocacy Network is proud to announce the beginning of a new college scholarship program for autistic students: the Autistic Scholars Fellowship.

The <u>ASAN</u> Autistic Scholars Fellowship program, a new ASAN project to advance campus leadership, will provide 3 to 5 autistic students \$5,000 tuition scholarships each to create systems change on their college campuses. Fellows will be required to establish or participate in a leadership role within an ASAN campus chapter or a disability rights student organization, work to promote Autistic culture and community, and take steps to improve disability accessibility and inclusion on their college campuses. Fellows are also expected to check in with ASAN on a monthly basis to receive support in achieving their advocacy projects. Applicants must be Autistic, be willing to publicly identify as such and

should have a strong interest in disability rights advocacy and activism.

Scholarship Applications

Completed applications for the January 2016 scholarship period are due on November 15. Application questions will ask students to describe the current problems for autistic and other disabled students on their college campuses and explain how their planned activities under the fellowship will enable them address these problems. ASAN staff will review completed applications and interview a select group of students starting in mid-November. They expect to inform fellowship recipients of their selection by mid-December.

Grafton, VA Toddler Connection

In partnership with the City of Winchester's Department of Social Services, <u>Grafton</u> provides early intervention services for children aged birth to age three. The Infant & Toddler Connection (ITC) of Shenandoah Valley is tailored to local children-from birth to age three-with disabilities.



The ITC program supports six different localities including Frederick County, Clarke County, Warren County, Page County, Shenandoah County and the City of Winchester.

The Infant & Toddler Connection of Shenandoah Valley teaches, coaches and mentors families of children who exhibit a developmental delay or a mental and/or physical condition that gets in the way of their development. Their staff are certified by the state as Early Intervention professionals and their clinical providers are all licensed in their disciplines.

She has a very keen understanding of medical ailments and disabling conditions resulting from excessive time spent in hospitals and outpatient rehab facilities.

and for people who need a Consumer-Directed Assistant. People wanting to become assistants can list their skills, availability, location, and contact information. People with disabilities that need assistants can search for a person to work with them that matches their needs.

The Arc of Northern Virginia has put together an incredible document to introduce individuals to consumer direction. Starting on page 8 of the document, there are very valuable insights into finding and managing qualified care providers. (Remember they are located in Northern VA, so the reimbursement rate is only relevant to NVA.)

General Strategies to find attendants:

- Relevant departments of local colleges.
- Your local department of social services likely has a list of people interested in working as attendants.
- Ask your school's paraprofessionals.
- Virginia Employment Commission
- Utilize sites such as:
 - Care.com
 - Craig's List
 - MySupport
 - SitterCity
 - ShareNetwork
